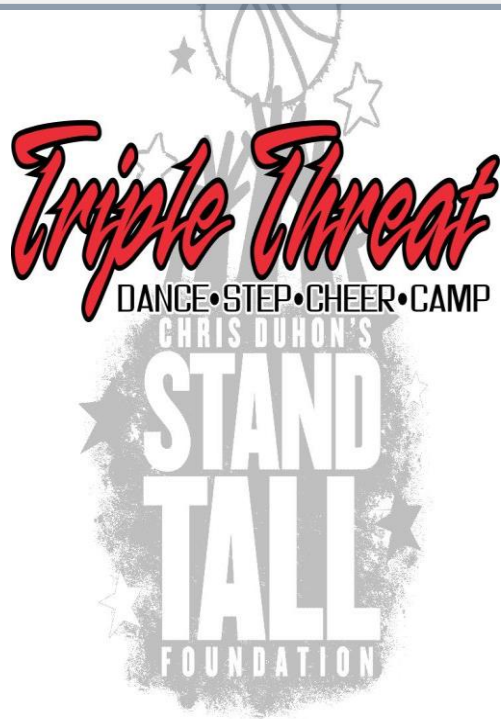

About the camp:

The Triple Threat Dance, Step & Cheer Camp was created by The Chris Duhon Stand Tall Foundation to provide recreational opportunities for children in need. Realizing that participating in the arts can be costly, the Stand Tall Foundation seeks to provide basic training in technique and choreography to prepare the campers for participation in school teams at the middle school and high school level.

Coaches volunteer their time and come from all facets of the arts. Each year we partner up with professional choreographers from all over the United States who volunteer their time and talent to our cause.

“When we recruit coaches, we aimed to find the best in the arts, past years coaches have been very talented and have inspired our youth”, said Andrea Duhon, Triple Threat Camp Founder and Director.

The five-day camp is designed for boys & girls, ages 5-16 and focuses on fundamental technique and choreography of Dance, Step and Cheer. From beginning to end, each day is crammed with a high-level of instruction in a fun and safe environment.

The camp will run daily from 9:00 a.m. – 4:00 p.m. with a final showcase at 2:00 p.m. on Friday.
